Player Waiver, Release of Liability, and Indemnification Agreement
This form <u>must</u> be turned in with your signed Application Form

I, the undersigned player, acknowledge, agree and understand that:

- 1. Voluntarily and of my own free will, I elect to participate as a member of the Palm Springs Senior Softball National League (hereinafter referred to as the "PSSSNL").
- 2. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players including, but not limited to, those hazards associated with other players; weather conditions; playing conditions; equipment; and illness. I understand this risk includes the exposure to or contraction of communicable diseases including, but not limited to, COVID-19.
- 3. I understand that sliding or diving into a base is allowed in the PSSSNL, and I understand sliding and/or diving into a base is dangerous to me and to other players and may result in serious injury or death.
- 4. I understand the very nature of the game of softball is hazardous and risky including, but not limited to, the acts of pitching; throwing; fielding and catching of the ball; swinging of the bat; running; jumping; stretching; sliding; diving; collisions with other players and with stationary objects; as well as field conditions; weather; and alike, all of which can cause serious injury or death to me and to other players.

Further, I the undersigned player, agree that in consideration for the right to play as a member of the PSSSNL and in consideration for permission to play on the fields arranged for by the PSSSNL:

- 1. I voluntarily elect to accept and assume all risks of injury or illness, regardless of the severity, and including death, that I may incur or suffer to myself and all risk of damage to or loss of property which may occur as a result of the following:
 - A. While practicing or playing as a member of the team so designated;
 - B. While serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and;
 - C. While on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
- 2. For PSSSNL games, practices, meetings and league-sponsored events, I acknowledge the following:

I release, discharge and agree to hold harmless and not to take any form of legal action against the PSSNL, its board members, officers, managers, umpires, scorekeepers, players (both full and part-time), field officers, sponsors, volunteers, agents or any person or entities associated with the PSSSNL, including SSUSA. This includes the cities of Palm Springs, La Quinta, Palm Desert, Thousand Palms and any other municipalities where games may be played, for any claim, damages, costs or cause of action which I have or may have in the future as a result of injuries or damages sustained or incurred by me from whatever cause including, but not limited to, the negligence, breach of contract or wrongful conduct of the parties hereby released.
